Dear P802.16e Balloting Group:

Thank you for your participation in the Sponsor Ballot of P802.16e/D5, which ran from 5 October to 4 November 2004.

The response to this ballot was quite high. The result was 74 Approve votes, 58 Disapprove votes, and 9 abstentions. We received 1977 comments. The IEEE 802.16 Working Group, acting as the Ballot Resolution Committee, has worked diligently to resolve these comments. As a result, we hope to satisfy many of the Disapprove voters during recirculation and bring the resulting ballot into approval status. A list of the Disapprove voters is included as an Annex to this cover letter.

We are requesting that the IEEE Balloting Center initiate a fifteen-day recirculation of the new draft P802.16e/D6 (file *P80216e_D6.pdf*), along with a marked-up copy (file *P80216e_D6delta.pdf*) with all changes indicated. In addition, we are including a report of the Disapprove comments received, as document IEEE 802.16-05/010 (file *80216-05_010.pdf*). We have chosen to report separately, in the spreadsheet IEEE 802.16-05/011 (file *80216-05_011.zip*), our responses to the 1075 comments of one voter, David James. Note that comments whose resolution has been explicitly accepted are not being recirculated. However, not all commentators have been consulted, so many of these resolutions may also turn out to be satisfactory to the commentator. In some cases, the comments and resolutions refer to document numbers of the form C802.16e-04/XX or C802.16e-05/XX. These documents are available at <http://ieee802.org/16/tge>.

Please take this opportunity to review the material. You are not obligated to reply; if you do not, your current vote will stand. Based on the changes to the draft or on the Disapprove comments and responses, you may change your vote and/or submit additional comments. If you wish to re-vote or comment, please keep the deadline in mind. Instructions have been provided by the IEEE Balloting Center.

If you have voted Disapprove as shown in the Annex, I urge you to review the comment resolution and let us know which, if any, of your comments have been satisfactorily resolved. If you choose to cast an Approve vote, we will assume that all of them are resolved to your satisfaction.
