Subject: Liaison statement concerning the IMT-Advanced development process

Dear Mr. Sakanaka,

Thank you for the continued collaboration on the IEEE Technology proposal for IMT-Advanced and related evaluation activities.

At its June 2010 meeting, ITU-R WP 5D developed correspondence with external organizations regarding the IMT-Advanced process. This correspondence, titled *LIAISON TO EXTERNAL ORGANIZATIONS ON THE SCHEDULE AND TECHNICAL AND ADMINISTRATIVE INPUTS FOR THE COMPLETION OF THE FIRST RELEASE OF RECOMMENDATION ITU-R M.[IMT.RSPEC]*, contains critical information on important milestones of the process, including various forms to be filled out by the RIT/SRIT Proponents, GCS Proponents, and Transposing Organizations. In response to this correspondence, the RIT/SRIT Proponents are requested to submit Form A to the ITU-R by 6 October 2010 providing notification of intention to submit GCS for an IMT-Advanced RIT.

IEEE intends to submit a GCS and therefore has drafted a Form A to notify ITU-R accordingly. IEEE is of the view that this Form A could be used by all of the IEEE Technology proponents (IEEE, Japan and TTA) to indicate their intent regarding the GCS.

Attached is the draft Form A that we have prepared. We welcome your feedback before our next Session (13-16 September 2010) on whether Japan agrees to be listed as a source as represented in the draft Form A. In such case, please provide us with the appropriate contact information.
